## Country specific metadata associated with national estimates for 2022Q2

The information below summarises metadata collected from countries in relation to the compilation and publication of European estimates of national accounts main aggregates for the 2022Q2.

Due to differences in the national transmission and publication patterns, the information is presented in chronological order, starting with T+30 and T+45 flash estimates published end July and mid-August and T+2 months estimates published in September.

The most recent metadata refer to data published in time for <u>Eurostat's 7 September 2022</u> <u>news release on GDP, employment and main aggregates</u>. Estimates from countries were provided in the end of August and were accompanied with the metadata explanations. Updated estimates are going to be provided in mid-October for T+110 database update.
