Eligible actions	Meetings, participation at events, publications, website, joint services, joint products, study visit
Eligible costs	Travel, accommodation, catering, interpreters' fees, consulting, translation, telecommunication and/or postal services, rental of venue for meetings and events, share of common costs related to joint publication and/or website
Non-eligible costs	 Costs incurred prior to the signing of the formal agreement for a full Cooperation Project Running costs of the project promoter
