

# RDPs 2014-2020: Monitoring data **EU Overview**


Situation at the end of 2016


This factsheet contains monitoring data aggregated at EU level (EU-28), providing a comprehensive overview of the state of play in the implementation of the EU rural development policy. In particular, Section 1 presents financial expenditures aggregated at EU level and broken down by Rural Development Priority, covering the period between 2014 and end 2016. Section 2 presents the progress realised towards EU common target indicators.

#### 1. Financial expenditure (EU-28)

This section presents information on the progress made on public financial expenditure until December 2016, aggregated at EU level (EU-28) and broken down by Rural Development Priority. This information includes planned, committed and realised expenditures, and the progress made towards achieving the EU planned expenditures. It observed that the implementation of Priority 4 (P4) 'Restoring preserving and enhancing ecosystems related to agriculture and forestry' is the most advanced, reflecting in part the high share of annual area-based payments under this Priority as compared to other Priorities with a higher emphasis on investment projects, which take more time to be realised.


Table 1: Overview of financial expenditures for rural development policy at EU level (EU-28) - Billion EUR
