

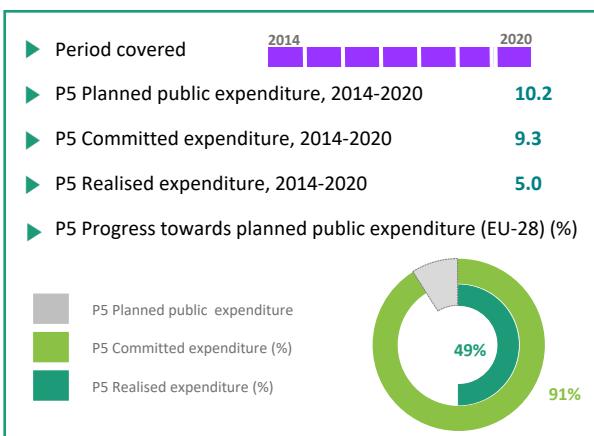
This factsheet contains monitoring data aggregated at EU level (EU-28), providing a comprehensive overview of the state of play in the implementation of the rural development Priority 5 (P5) 'Promote resource efficiency and support the shift towards a low carbon and climate resilient economy in agriculture, food and forestry sectors'. In particular, Section 1 presents financial expenditure aggregated at EU level and broken down by Member State (MS), covering the period between 2014 and end 2020. Section 2 presents the progress realised towards the EU common target indicators linked to P5.

1. Financial expenditure (RD Priority 5)

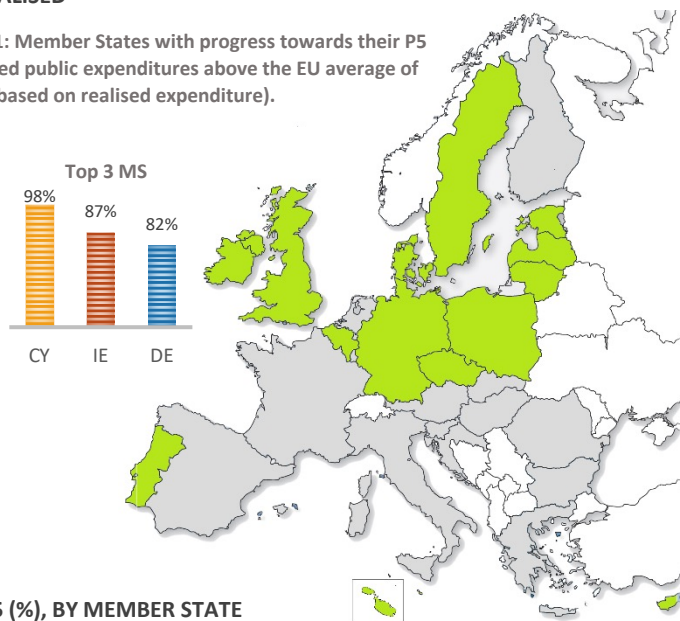

Table 1: Overview of financial expenditure for P5 at EU level (EU-28) - Billion EUR.

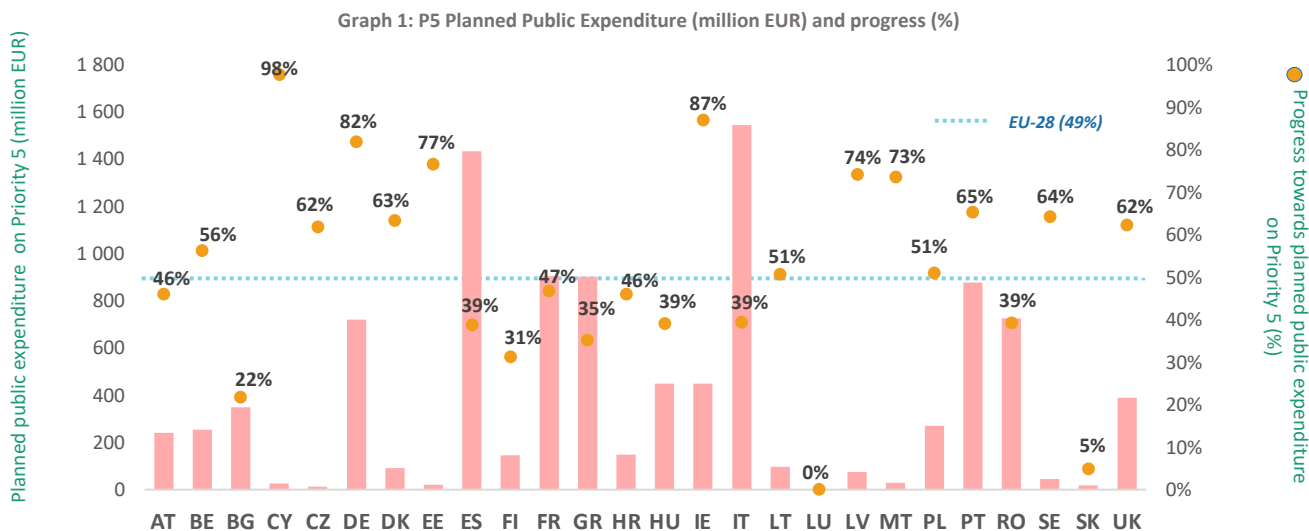


Map 1: Member States with progress towards their P5 planned public expenditures above the EU average of 49% (based on realised expenditure).

Source of information: All data presented in this factsheet is collected from the Annual Implementation Reports (AIRs) submitted by Member States to the Commission by the end of June 2021. Data was retrieved in January 2022 from the 2021 AIRs.

In this factsheet, public expenditure means total public expenditure (= EAFRD + Member States matching funds + any national top-ups). Due to rounding, there may be small discrepancies between some figures presented. Data illustrated cover the programme implementation period between 2014-2020.
