

## **Specific Privacy Statement**

### **Open public consultation related to the Impact assessment for the revision of the EIS/EIF**

#### **1. OBJECTIVE**

The European Commission has mandated KURT SALMON in order to carry out the Impact Assessment for the revision of the EIS/EIF.

In that regards, the objective of this consultation is to receive the views of all the stakeholders concerned by the topic of this study.

Received contributions, together with the identity of the contributor, will be published on the Internet, unless the contributor objects to publication of the personal data on the grounds that such publication would harm his or her legitimate interests. In this case the contribution may be published in anonymous form. Otherwise the contribution will not be published nor will, in principle, its content be taken into account.

As far as this consultation implies the collection and further processing of personal data, Regulation (EC) 45/2001, of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Union institutions and bodies and on the free movement of such data, is applicable.

In this context, KURT SALMON is considered to be Processor of the data collected, acting on behalf of and under the responsibility of the Head of Unit DIGIT.B.6 of the European Commission, which is considered as Controller.

#### **2. WHAT PERSONAL INFORMATION DO WE COLLECT AND THROUGH WHICH TECHNICAL MEANS?**

##### **Identification Data**

The personal data collected and further processed are data necessary for the participation in the consultation, such as name/surname/profession/ postal & e-mail addresses/phone number, of the contributors, including their views on the topics concerned. This data may be used for further contact in case more details regarding collected data are needed.

The processing operations on personal data linked to the organisation and management of this consultation are necessary for the management and functioning of the Commission, as mandated by the Treaties, and more specifically in Article 5 of TEU, Article 13 TEU and Articles 244-250 TFEU, and in accordance with Article 1 and Article 11 of TEU.

##### **Technical information**

The EU Survey system uses session "cookies" in order to ensure communication between the client and the server. Therefore, your browser must be configured to accept "cookies". However, it does not collect personal or confidential information of any kind, nor any IP address from your PC. The cookies disappear once the session has been terminated.

### **3. WHO HAS ACCESS TO YOUR INFORMATION AND TO WHOM IS IT DISCLOSED?**

The access to all personal data as well as all information collected in the context of this consultation is only granted through User Id/Password to a defined population of users, without prejudice to a possible transmission to the bodies in charge of a monitoring or inspection task in accordance with Union legislation. The users concerned are members of the DG DIGIT B.6 Unit organising the consultation and responsible for the study contract, any other Commission officials concerned by the topic and KURT SALMON, the contractor.

No personal data is transmitted to parties which are outside the recipients and the legal framework mentioned.

The European Commission will not share personal data with third parties for direct marketing purposes.

### **4. HOW DO WE PROTECT AND SAFEGUARD YOUR INFORMATION?**

Your replies, together with your chosen language used for drafting the reply, are recorded in a secured and protected database hosted by the Data Centre of the European Commission, the operations of which abide by the Commission's security decisions and provisions established by the Directorate of Security for this kind of servers and services. The database is not accessible from outside the Commission. Inside the Commission the database can be accessed using a UserId/Password.

The collected personal data and all information related to the above mentioned consultation is also stored on a computer of the external contractor, acting as processor, who has to guarantee the data protection and confidentiality required by the Regulation (EC) 45/2001.

Access to the EU Survey application is via a non-encrypted connection using the normal http protocol.
