THE EUROPEAN COMMISSION (hereinafter referred to as 'the Commission'),

Having regard to Regulation (EU, Euratom) No 966/2012 of 25 October 2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union¹ (hereinafter referred to as the 'Financial Regulation'), and in particular Article 133 thereof,

Having regard to Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council on the financial rules applicable to the general budget of the Union² (hereinafter referred to as the 'Rules of Application'), and in particular Article 204 thereof,

Having regard to Council Decision No 2007/125/JHA of 12 February 2007 establishing a specific programme "Prevention of and Fight against Crime", as part of the General Programme on Security and Safeguarding Liberties³ (hereinafter referred to as the 'Programme', and in particular Article 4.1 thereof,

Whereas:

- (1) The Commission adopted a work programme and financing decision for 2013 on 19.09.2012, which contains the provision to award action grants;
- (2) A call for proposals for action grants has been published which establishes the objectives and priorities and the eligibility, exclusion, selection and award criteria;
- (3) An Evaluation Committee was appointed pursuant to Article 204(1) of the Rules of Application in order to evaluate the applications submitted under the above mentioned call for proposals and to identify the proposals which may receive funding;
- (4) The Evaluation Committee has established an Evaluation Report which contains all the information required under Article 204(4) of the Rules of Application;
- (5) The Committee established by Article 8 of Council Decision No 2007/125/JHA of 12 February 2007 has been consulted under the advisory procedure according to Articles

7(6) and 9 of the same Decision on the proposed award of grants to proposals pertaining to the Programme and has given a favourable opinion;

HAS DECIDED AS FOLLOWS:

Article 1

Selected Proposals

The proposals listed in Annex 1 to this Decision shall be awarded a grant under the specific programme "ISEC" – call for proposals JUST/2013/ISEC/DRUGS/AG, up to the maximum amount indicated in that Annex. The overall amount of financing provided is **4,863,429.06** € (Total amount).

Article 2

Reserve list

The proposals listed in Annex 2 to this Decision shall be awarded a grant under the specific programme "ISEC" – call for proposals JUST/2013/ISEC/DRUGS/AG, up to the maximum amount indicated in that Annex, subject to the availability of funds.

Article 3

Rejected proposals

The proposals listed in Annex 3 to this Decision are not selected for financing under the specific programme "ISEC" – call for proposals JUST/2013/ISEC/DRUGS/AG.
