COMMISSION IMPLEMENTING DECISION

of 30.3.2015

concerning the adoption of the work programme for 2015 and the financing for the implementation of the Justice Programme

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1382/2013 of the European Parliament and of the Council of 17 December 2013 establishing a Justice Programme for the period 2014 to 2020¹, and in particular Article 10 thereof,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union², and in particular Article 84(2) thereof,

Whereas:

- (1) In order to ensure implementation of the Justice Programme it is necessary to adopt a financing decision and the work programme for 2015. Article 94 of Commission Delegated Regulation (EU, Euratom) No 1268/2012³ establishes detailed rules on financing decisions.
- (2) It is appropriate to authorise award of grants without a call for proposals to the identified in the work programme and for the reasons provided therein.
- (3) This Decision should allow for the payment of interest due for late payment on the basis of Article 92 of the Financial Regulation and Article 111(4) of Delegated Regulation (EU, Euratom) No 1268/2012.
- For the application of this Decision, it is appropriate to define the term 'substantial (4) change' within the meaning of Article 94(4) of Delegated Regulation (EU, Euratom) No 1268/2012.
- (5) The measures provided for in this Decision are in accordance with the opinion of the Justice Committee established by Article 11 of Regulation (EU) No 1382/2013.

HAS DECIDED AS FOLLOWS:

Article 1 The work programme

The annual work programme for the implementation of the Justice Programme for 2015, as set out in the Annex, is adopted.

Article 2 Union contribution

The maximum Union contribution for the implementation of the programme for the year 2015 is set at EUR 48 051 000, and shall be financed from the appropriations entered in the following lines of the general budget of the European Union for 2015:

- (a) budget line 33 03 02: EUR 14 415 000
- (b) budget line 33 03 01: EUR 30 636 000
- (c) budget line 33 03 03: EUR 3 000 000

The appropriations provided for in the first paragraph may also cover interest due for late payment.

Article 3 Flexibility clause

Cumulated changes to the allocations to specific actions not exceeding 20% of the maximum contribution set in Article 2 of this Decision shall not be considered to be substantial within the meaning of Article 94(4) of Delegated Regulation (EU, Euratom) No 1268/2012, where those changes do not significantly affect the nature of the actions and objective of the work programme. The increase of the maximum contribution set in Article 2 of this Decision shall not exceed 20%.

In implementing this decision, the authorising officer responsible may apply the type of changes referred to in the first paragraph in accordance with the principles of sound financial management and proportionality.

Article 4
Grants

Grants may be awarded without a call for proposals to the bodies identified in the Annex, in accordance with the conditions specified therein.
