



EC-ILO Joint Conference on Domestic Workers and Occupational Safety and Health



12-13 November 2018, Brussels



Background

Encouraging Members States to ensure a broad coverage of occupational safety and health (OSH) policies is one of the priorities identified in the Commission Communication Safer and Healthier Work for All.

The sector of domestic work (persons employed for household work in private households) is one of the areas identified as those where new initiatives at EU level are most needed.

While the EU legislative framework on occupational safety and health does not include domestic workers under its scope, around half of the Member States have national OSH provisions covering this sector.

On the other hand, the Domestic Workers Convention (No. 189) of the International Labour Organisation (ILO), which do provide coverage of domestic workers' OSH rights have been ratified by only a few Member States.

The European Parliament, with its Resolution of 28 April 2016 on women domestic workers and carers in the EU, and the European Economic and Social Committee with its Opinion on 'The rights of live-in care workers' of 21 January 2016, have raised their concern about this issue too. They are both calling upon EU Member States to ratify Convention 189 and inviting the Commission to take initiatives in this area.

Therefore the Commission in cooperation with the ILO has decided to organise a high level conference on OSH and domestic work. This conference will bring together representatives from national governments, labour inspectorates, social partners, EU institutions /agencies, and international experts with the aim to:

- Take stock of the situation as regards domestic work and OSH in the EU;
- Promote an exchange of views, experiences and good practices between EU and international partners on the nature, scope and results of their respective OSH policies in the area of domestic work; and
- Encourage the ratification of the ILO Domestic Workers Convention 189.

Marianne **THYSSEN**

Marianne Thyssen is Commissioner for Employment, Social Affairs, Skills and Labour Mobility. Her portfolio includes overseeing European Union policy on employment, social affairs, vocational training, skills, labour market reforms and social inclusion, including workplace equality legislation. She is also responsible for the statistical office of the European Union (Eurostat). She studied Law at the Catholic University of Leuven where she had her first job at the Law Faculty. Prior to her political career, she was working for UNIZO for more than 10 years (SME representative organisation). After that, she served as a Member of the European Parliament (1991-2014) and as Vice-Chair of the Economic and Monetary Affairs Committee. Marianne Thyssen was also the party leader of the Flemish Christian-Democratic Party (CD&V) and the First Vice-President of the EPP Group in the

European Parliament. She was elected Vice-President of the European People's Party in October 2015.



Nancy **LEPPINK**

Nancy J. Leppink is Chief of the International Labour Organization's Labour Administration, Labour Inspection and Occupational Safety and Health Branch. Prior to joining the ILO, Ms. Leppink headed the United States Department of Labour, Wage and Hour Division. Under her leadership the Wage and Hour Division was actively involved in the ILO's development of the Domestic Worker Convention and the development of federal regulations in the United States protecting home care workers. Ms. Leppink has over 25 years' experience as a strategist and leader in employment and labour policy, law, administration, enforcement and compliance. She has significant experience at national, international and state levels working with public, private and non-

profit sectors. Her knowledge of policy and law extends to the areas of employment and labour standards, occupational safety and health, and labour and human rights.



Beate HARTINGER-KLEIN

Beate Hartinger-Klein is Federal Minister of Labour, Social Affairs, Health and Consumer Protection in Austria. Among her varied and extensive area of responibility OSH plays an important role. The labour inspectorates are part of the Ministry.

Beate Hartinger-Klein studied Social and Economic Sciences at the Karl Franzens University Graz. She worked in different managing functions in the health sector. In her political career she served as a member of the Provincial Parliament of Styria and of the National Council (Lower House of the Austrian Parliament). She was appointed Minister of Labour, Social Affairs, Health and Consumer Protection in December 2017.



Tania González **PEÑAS**

Ms. González Peñas is VicePresident of the EP group GUW/NGL. Spanish MEP of PODEMOS political party, she is member of the Committees of Employment and Social Affairs (EMPL) and Transport and Tourism (TRAN), as well as VicePresident of the Delegation for the relations with Andean Community (DAND).

Ms. González Peñas was rapporteur to the EMPL Opinion on "Female domestic workers and carers in the EU" of the Kuneva INI report and in this Committee she launched the initiative for a Pilot Project on the "Promotion of the voucher system and cooperatives of domestic workers in Europe" that was endorsed by the European Parliament during the votes of the EU general

budget of the last year, which is currently being implemented by the European Commission.





Adam ROGALEWSKI

Adam Rogalewski, is a lawyer and an acting head of the international department of the Polish Confederation of Trade Unions, OPZZ. Since 2015, he has been a member of the European Economic and Social Committee (EESC). He worked for a British trade union, Unia (2008 – 2012), where he was responsible for Central Eastern European (CEE) workers and in the Swiss trade union, Unia (2012- November 2018), where he was also responsible for CEE workers, particularly in construction and care employees.

He was doctoral student at the London Metropolitan University and his research thesis focusses on trade unions' policies on the integration of Polish migrants. He submitted his thesis in October 2018. In October 2018, he published an academic article in Transfer, European Review of Labour and Research: (2018) Organising and mobilising Central and Eastern European migrant women working in care. In Switzerland, he supported workers in establishing a Swiss-wide group of live-in care workers in Unia (http://www.gutepflege.ch/cee-en/), which resulted in the preparation of an EESC opinion on the rights of live-in care workers), the first European wide policy document on this subject. In 2017 and 2018 as a follow up to this opinion the EESC organised a study visits in the UK, Germany, Italy, Poland and in 2019 in Sweden. The report from these visits will be presented in the first half of the 2019.

Stefan **OLSSON**

Director for Employment, DG Employment, European Commission

A Swedish lawyer with degrees in international, EU and tax law. Having joined the European Commission in 1996, he dealt with gender equality, fundamental rights issues as well as social dialogue. He was assistant to the Director General for Employment and Social Affairs (2000-2005) before leading units dealing with anti-discrimination law and policy, as well as administrative affairs and social inclusion.

In 2015 he took up the position of Director in DG Employment responsible for management of the European Social Fund in Romania, Bulgaria, Malta and Spain, implementation of the Employment Strategy through tools such as the Youth Guarantee, the Long Term Unemployment Recommendation and the network of Public Employment Services, as well as legislative and policy issues relating to working conditions including health and safety at work.

Born in Italy in 1956.

Background: Philosophy, Anthropology, Social sciences (University of Rome, Konstanz, Aachen) Joined the Commission in 1990. Since 2001 Policy Officer in DG EMPL (Employment, Social Affairs and Inclusion), Unit B3 (Health, and Safety).

Head of the Secretariat to the Advisory Committee on Safety and Health at Work (ACSH).

Responsible for OSH International Relations aspects in Unit B3.

Other main areas of activity in the Commission: OSH Strategies, OSH legislation (ergonomics), EU OSH Information System.

Jean-François LEBRUN is currently active senior at the European Commission in charge of "Personal and Household Services" (PHS) and expert in the Structural Reform Support Service.

Jordi **CURELL**

Jordi Curell has a law background and since 1986 has worked in different positions in the European Commission, including in DG Employment, where he was responsible for coordinating the preparation and implementation of the European Social Agenda and afterwards in DG Education and Culture at the head of the Directorate for "Higher Education and International Affairs", where he led the negotiations on the new Erasmus+ programme.

Jordi Curell is presently Director for "Labour Mobility" in the Directorate General for Employment, Social Affairs and Inclusion. The Directorate is responsible for enhancing labour and social considerations in the EU's overall external and trade policy, as

well as developing the relations with international organisations, third countries and regions, including the EU strategic partners and the European neighbourhood in these fields. He is in charge of advancing and supporting high quality labour mobility within the EU by promoting free movement of workers and by facilitating the coordination of social security systems.
