Purpose of the evaluation

Assess

implementation

of the EU Disability Strategy (EDS) at EU and Member State level

Evaluate

effectiveness, efficiency, relevance, coherence and EU added value of the Strategy

Provide conclusions and recommendations to support the European Commission's review of the Strategy and formulation of future policy development




Share of EU level actions implemented for the 8 areas of action



Factors influencing effectiveness of the EDS

Success factors in implementing the Strategy

- Contributed to a change in the overall disability policy discourse towards a human rights-based approach
- Different forms of implementation
- Utilisation of existing policies and EU Funds
- Exchange of good practices and awarenessraising
- Institutional improvements in policy development

Factors hindering the disability strategy to make progress

- Design of the Strategy could have been more closely linked to the CRPD
- Strategy could have better addressed non-visible disability issues
- Assessing progress during the delivery period was difficult
- Focal points within European Commission DGs would have facilitated greater mainstreaming
- Varied capacity among Member States and regions to implement policy





EU initiatives have helped to improve the situation for persons with disabilities in the last 10 years




Overall, EU initiatives have helped to improve the situation for persons with disabilities in the last 10 years: in your Member State?

There have been significant achievements from the EDS

- The EU has made significant progress towards meeting the objectives of the Strategy but further progress is needed.
- The Strategy contributed to a change in the overall disability policy discourse towards a human rights-based approach
- The EDS influenced the development of important legislative instruments and policy development
- The Strategy supplemented and supported Member States by providing important tools but the influence of the Strategy at Member State level was limited





A monitoring framework and resource for implementation may have improved implementation

- Outcome indicators to monitor change over time between people with disabilities and people without disabilities, between different groups, and different countries would have provided a useful framework to understand progress
- The coherence of the Strategy with other EU policies may have benefitted from greater mainstreaming through dedicated responsible experts in European institutions
- A dedicated budget for implementation of the Disability Strategy would have enabled more actions to be implemented



Implications for future EU Strategy (1/2)

Design

- Disabled people's organisations should have a central role in design, implementation and monitoring of new strategy
- All eight areas of action included in the Strategy continue to remain relevant
- The EU should take legislative action to implement the requirements of the CRPD and address the current gaps, particularly in the area of consumer protection and equality
- A disability-specific OMC should be considered, as well as further EU funding

Deliver

- A dedicated budget for implementation of the Disability Strategy, used in combination with existing EU funds, could increase efficiency by enabling more actions of scale
- Strengthened coordination within and between EU institutions, and greater awareness raising efforts to ensure persons with disability are aware of opportunities





Implications for future EU Strategy (2/2)



Monitor and evaluate

- A future Strategy should have clear indicators, benchmarks, and interim timelines in order to monitor implementation progress
- Disaggregation of data on intersectionality (e.g. women with disabilities) should be considered in the monitoring of future EU Disability Strategy
- New data published through the Regulation on Integrated European Social Statistics should be used to monitor and evaluate the impact of disability mainstreaming legislative and nonlegislative actions;
- Consideration in the design and monitoring of future Strategy should include the extent to which gaps between EU and Member State policy objectives can be addressed
