The European Pillar of Social Rights Action Plan



This Action Plan explains how the European Pillar of Social Rights will improve your life.

The European Union's Action Plan has 3 main areas, with targets to reach in each of them by 2030:



1. Creating more and better jobs for everyone;

TARGET: a **majority** of all people should have a job.

A majority means more than half.

We will focus on women and young people.

2. Making sure everyone has a fair chance to get the skills they need;

TARGET: a majority of all people should get some training and have basic computer skills.



3. Including people so that everyone is able to take part in the world around them and no one is left out.

TARGET: reduce the number of people, especially children who:

- could become very poor.
- are not involved in daily life.

What the European Union is doing to create more and better jobs for people



The European Union is creating more work in **new technology** and **green jobs**.



New technology means new ways of working using computers, phones and the internet.



Green jobs are jobs that help protect the environment and help to reduce pollution.



In the future there will be many more jobs for people in community organisations and health and social care organisations.



The European Union has set up:

- many initiatives to help young and older people get the skills they need to get good jobs;
- ways for companies to work and trade more easily.

The European Union wants to improve all workers' lives, including people who work for themselves or work from home.

The European Union:

- makes sure all workers are healthy and safe;
- makes it easier for everyone to change jobs or look for new work;
- makes it easier people to go to other European Union countries to work.

What the European Union is doing to make sure you get the skills you need



We want everyone to get a better education and learn new skills to have more opportunities.



The European Union:

helps universities to give training to organisations as well;



• helps people to carry on learning throughout their lives;



 looks to bring in new workers with skills from outside the European Union;



 helps to give everyone a fair chance to get a good job;



 makes sure women get the same opportunities as men;



The European Union wants women and men to get the same pay for the same work.

The European Union helps people who can't afford the basic things they need to live.




The European Union wants to make sure everyone:

In 2025, we will review the Action Plan.

We will decide if anything needs to be changed to achieve our targets by 2030.
