
### Access to social protection

• Blurring of boundaries between employment and self-employment

## Distribution of economically dependent as share of solo self-employed, % of entire workforce (Source: European Working Conditions Telephone Survey, 2021)






#### Access to social insurance benefits through clarification of selfemployed/employed status – focus on platform work

  - Collective bargaining










# Income stabilising coefficient for employees and self-employed in EU Member States

# Recent and proposed changes in access to sickness cash benefits

- Portugal cut waiting period for self-employed from 30 to 10 days in 2018, but remain different from employees
- France extended access sickness benefit to additional liberal professions and those previously members of other social insurance schemes
- Cyprus plans to extend sickness benefit to self-employed
- Estonia plans extension of universal healthcare
